

Long-Term Care Home Wait List Information

Choosing a long-term care home (LTCH), also known as a nursing home, is a major decision for you and your family. It is important to have all the information you need in order to choose the home that is right for you.

It's a good idea to visit the homes you're interested in, and your LHIN Care Coordinator can support you through the process.

When you apply, you can choose up to five (5) homes in order of preference. How long you wait depends on the size of the waiting list in each home and the urgency of your need(s). The more urgent your need, the more choices you will be asked to make.

There are [36 LTCHs](#) throughout Southeastern Ontario. Some homes are privately owned and some are non-profit homes operated by municipalities or charitable organizations.

All homes are licensed and inspected by the Ontario Ministry of Long-Term Care. Standards of care are governed by provincial legislation, and each home is accountable for the quality of care, programs and services it provides.

This document enables you to see the size of the waiting list for each LTCH, organized by geographical location. If you move to a home that is not your first choice, you may stay on the waiting list for your first choice.

Eligibility

To qualify to move into a LTCH, you must be 18 years of age or older and have:

- A valid Ontario Health Card;
- Health care needs that cannot be met with any combination of caregiving, care in your home, or care in your community; and
- Health care needs that can be met in a LTCH.

Placement priority categories for individuals

1. Crisis: People requiring immediate admission resulting from the person's condition and/or circumstances.

2. Spousal/Partner Reunification: A spouse or partner seeking to be reunited with their loved one who already resides in that specific LTCH. The applicant must meet eligibility criteria in his or her own right.

3. Ethno-cultural/Religious: Person of the religion, ethnic origin or linguistic origin primarily served by the home, who meets one of the conditions listed below in 4 A.

4 A. Person living in the community who has high-care needs, requiring personal care at frequent intervals throughout the day, but can be supported at home until a bed becomes available. Also includes a person occupying a bed in a hospital waiting for LTCH bed, and anyone residing in a LTCH wishing to transfer to their first choice home

4 B. Person living in the community who does not meet the care requirements in 4 A, or someone already residing in a LTCH and waiting to transfer to another home that is not their first choice facility.

Readmission Category: Applicant was a long-stay resident in the home but was discharged after a medical or psychiatric absence that exceeded the time permitted in regulation, or the applicant was a long-stay resident in the home but was discharged due to an emergency in the home.

Note: Both of the above applies only to the LTCH from which the person was most recently discharged.

Veteran's Priority Access Beds: Designated beds accessible to qualifying veterans. These individuals are a higher priority for placement in these beds than non-veteran applicants.

Notes:

These figures represent wait times for the 90th percentile in each category, based on the total number of people waiting for long-term care as of January 15, 2021. These wait times will vary depending on accommodation availability, and the gender and placement category of the person waiting for long-term care. Individual patients may select up to 5 Long Term Care Homes and would be reflected on more than one waitlist.

The average number of beds available is based upon the number of beds available per month for the last twelve months from January 15, 2021.

Ninetieth percentile waiting time means 90 per cent of the people admitted to a long-term care home are admitted by this time. For example, a 90th percentile waiting time of 200 days means that 90 per cent of patients admitted were admitted within 200 days of applying to the long-term care home.
