Community Paramedicine

In 2014, the Ministry of Health and Long-Term Care provided a \$6 million investment to support the expansion of community paramedicine programs in Ontario. Four programs in the HNHB LHIN region were approved for recurring ontime funding. Those areas are Niagara, Brant, Hamilton, and Norfolk.

This funding request is the result of the four community paramedicine programs that each submitted a business case for consideration of LHIN one-time funding for 2017-18.

All four proposals were evaluated by the HNHB LHIN using the LHIN's Decision Making Framework tool along with the Community Paramedicine Framework developed in conjunction with the ministry and LHIN Leads.

Alzheimer Society of Brant Haldimand Norfolk Hamilton Halton Self-Care for Caregiver Program

In December 2015, the HNHB LHIN Board approved one-time funding for the Self-Care for the Caregiver program for the remainder of the 2015-16 fiscal year and for 2016-17. It was noted at the time of this approval that the Board would review the program performance in order to make future funding decisions.

The Self-Care for the Caregiver program sessions have been held in Hamilton, Burlington, Simcoe, Caledonia, Brantford, and Niagara. A session is planned for Six Nations starting in February 2017. 96 individuals completed the course in six months with a participant satisfaction rate of 100%.

The Alzheimer Society serves over 4,000 caregivers who could potentially benefit from this program.

Tabor Manor

In March 2015, the HNHB LHIN Board approved Tabor Manor to receive one-time funding for fiscal years 2015-16 and 2016-17 to support increased staffing at Tabor Manor's Mapleview and Evergreen apartments to comply Fire Regulations and meet the evacuation requirements while they underwent capital renovations. This continuation of funding will allow Tabor Manor to continue to retain additional staffing resources until the approval of their Fire Plan.

The need for up to two years funding will be re-evaluated if the revised Fire Plan is approved.

Interim Long-Term Care Beds

In 2015-16, the HNHB LHIN Board of Directors approved one-time funding for two years to support 14 interim beds across eight long-term care homes in the HNHB LHIN. Seven of the eight homes all report wait lists of individuals waiting for admission.

This funding request is to ensure that patients waiting in the hospital for admission. to a long stay bed in a long-term care home are cared for in a home like environment that includes the care and services specifically designed to meet their needs.

This approval is an important strategy to improve overall patient flow and assists LHINs in addressing hospital Emergency Department wait times, Alternate Level of Care pressures, and facilitate faster discharges to long-term care homes.

Key Points of Discussion:

- Concern was raised with regards to transportation access to healthcare services for those residents living in Niagara-on-the-Lake, Port Colborne, and Fort Erie. It was noted the planning of services will be developed to meet the demographic needs within each of these communities. The Regional Municipality of Niagara is scheduled to review the transportation plan in March 2017.
- Concern was identified as to the services that will be provided in the communities of Fort Erie, Port Colborne and Niagara-on-the-Lake.
- The Niagara Health System continues to advocate for access to transportation and participates as a member of the Niagara Region Transportation Master Plan Stakeholder Advisory Group.
- It was noted that the Niagara Health System is planning on developing future services and programs that will be aligned with demographic trends in the region. This may include the transfer of diagnostic imaging to smaller areas, after-hours access, and working with physicians so better communication of services is provided to patients.
- It was noted that a greater level of detail regarding programs and services will be incorporated as part of the Stage 2 submission.
- It was noted that the majority of healthcare services are based at the St. Catharines site. This has been done to maximize the existing site and provide services based on the populations the hospital serves (St. Catharines, Thorold, Niagara-on-the-Lake, and Niagara Falls).
- It was noted that the Mental Health beds are based at the St. Catharines site but that there are community based mental health programs throughout Niagara.
