Key Points of Discussion:

- The Voices in the Community Video is about Ruth's Story. Ruth is a resident of Simcoe living with Diabetes and she talks about the Haldimand Norfolk Diabetes Program.
- It was noted that the proposed Bill 41 was introduced into legislature on October 6 and is currently in 2nd reading. The HNHB LHIN Board Members attended a webinar that identified changes in Bill 41 when compared to Bill 210.
- It was noted that the LHIN will not be doing any community engagement prior to the by-election in the area of Niagara West Glanbrook. Engagement is currently being done in other LHIN areas with regards to sub-region planning.
- It was noted the Ministry of Health and Long-Term Care is investing 85 million dollars in the recruitment and retention of staff in primary care organizations across Ontario. The HNHB LHIN received \$753,200 for this purpose
- Additional base-funding of 8.4 million dollars will be given to HNHB LHIN hospitals in 2016-17 to address capacity and access.
- The Board was advised that three applicants from the HNHB LHIN were recognized as honour roll members of the Minister's Medal Awards. Those honour roll recipients are Mobile Crisis Rapid Response Teams, Screen for Life Mobile Cancer Screening Coach, and HNHB Behavioural Supports Ontario Hospital Clinical Leader Program. Congratulations to these honour roll recipients.
- Of special note, Michael Shea our Board Chairs term has ended as of October 26, 2016. Michael Shea has provided incredible leadership and guidance over the past six years. Michael has been an excellent Board Chair and he will be missed. The HNHB LHIN Board Members and staff want to thank Michael and wish him well.
