B. Education/Generative Discussion

B.1 Integrated Health Service Plan 2016-19 Achievements

Key Points of Discussion:

- The 2016-19 Integrated Health Service Plan (IHSP) was finalized in 2015, prior to the Patients First Act 2016 that directed the asset transfer of the Community Care Access Centres to the LHINs.
- The Patient and Family Advisory Council (PFAC) has communicated an interest in co designing the health system. The PFAC is aligning it's priorities with those of the provincial PFAC.
- Clinical innovations developed in HNHB LHIN have been identified for potential scaling across the province (e.g. Indwell program)
- 156 surge beds temporarily implemented across the system with a combination of base and on time funding.
- It was noted that the IHSP represents HNHB's strategy plan. Specific targets and expectations are addressed in the Annual Business Plan.

E.1 Integrated Health Service Plan 2019-2022

Key Points of Discussion:

- While a new provincial mandate letter has not been received, the 2019-2022 IHSP has been developed utilizing ministry identified priorities (hospital overcrowding, mental health and addictions, long-term care, home care, and capacity planning). Extensive stakeholder engagement likewise informed the development of IHSP priorities. The IHSP builds upon achievements from previous IHSPs.
- Work with French language Entités assists with IHSP planning. The HNHB CEO will be engaging at the Entity Board in October. It was noted that the

health care system would benefit from a mechanism to inform HSPs that all stakeholders have a responsibility for ensuring that health system processes are viewed with a Francophone and Indigenous lens, operationally as well as philosophically. Barriers to operationalizing the philosophy were discussed (e.g. lack of training in French, gap between speaking French and providing medical services in French, etc.)

- LHIN staff highlighted top-in-province patient innovation (e.g. Digital Health).
 Opportunities for innovation are identified by HSPs, SPOs, and LHIN staff, reviewed and assessed by the LHIN Executive Team, with ultimate responsibility residing with the CEO.
- It was noted that plans outlined in the IHSP must be delivered within existing funding. Additional funding is not anticipated.
